



### Introduction

#### **Event**

After rally is over a small speech on Environment Protection was given by Mr. Sunil Vasaikar & Mr. Sunil Thakur & the event was started. The employees of BGPL volunteered their time and labor for the social cause. The event started at 04:30 am under the pleasant sunshine.



As all the participants moved around finalizing the arrangements and finishing the jobs assigned to each, the employees of BGPL began the drive one by one. At the same time, employees who volunteered to help in the tree planting programme began their warm-up to make necessary arrangements.

After explaining the procedure to be followed while plantation, the tree planting programme began. The first sapling was planted by Mr. Sunil Thakur. Then the whole team; inclusive of the contractors and BGPL employees; picked up saplings, removed the bag around them, placed them in the pit, filled the pit with soil and watered the plants. Some of the employees carried cans full of water to the saplings, and some participants raked the soil into the pits. All in all, 30 saplings were planted within 30 minutes!
